1	Qurban Panhwar vs Zahid Malik Case	<p>The Executive Committee (EC) has completed its review of the matter brought forward by SANA members Qurban Panhwar and Zahid Malik. After a comprehensive examination of all submitted evidence and valuable input from past EC members, the EC unanimously determined that the event in question was organized by a private party and is not connected to SANA. Therefore, the case is dismissed without further action.</p> <p>To ensure SANA remains focused on its core mission of serving our community, the EC kindly requests that members refrain from bringing personal disputes for resolution. We are committed to fostering unity and working together for the betterment of our community in North America and our homeland.</p>
2	Latif Nizamani Case	Given that the President had previously forwarded this case to the Conflict Resolution Committee, no further discussion occurred.
3	Imtiaz Shaikh Case	Following a thorough review and discussion with current EC members who were part of the last EC, the EC determined that there was insufficient evidence to support the allegations and dismissed the case.
4	WhatsApp Moderation and SOP to implement code of conduct	It was agreed by majority of EC that messages exceeding seven numbers by any members should be warranted and subsequently be removed from the group. The detailed SOP will be issued very soon.
