

# SANA's 41 Houston Convention 2025 Event Disclaimer Policy

By registering for, attending, or participating in any way in the SANA's 41st Houston Convention 2025 (the "Event"), you (the "Attendee") agree to and acknowledge the following terms and conditions.

## 1. Assumption of Risk and Release of Liability

The Attendee acknowledges and understands that their attendance at the Event is entirely at their own risk. The Houston Convention Organizing Committee, the SANA Executive Committee, and all associated volunteers, sponsors, and vendors (collectively, the "Event Organizers") shall not be held liable for any injury, loss, damage, or theft of personal property, or any other incident, whether directly or indirectly related to the Event. The Attendee, for themselves, their heirs, and their assigns, hereby releases, waives, and forever discharges the Event Organizers from any and all claims, demands, damages, and causes of action whatsoever that may arise from or relate to their participation in the Event.

## 2. Convention Registration & Refund Policy

- \* Registration Fees: All registration fees are non-refundable unless otherwise specified in writing.
- \* Cancellation Policy: All sales are final. The Event Organizers will not issue refunds for cancellations due to unforeseen circumstances, including but not limited to travel disruptions, personal emergencies, or changes in professional schedules.
- \* Transfer of Registration: In some cases, and with prior written approval from the Event Organizers, an Attendee may be permitted to transfer their registration to another individual.
- \* Event Cancellation: In the unlikely event that the Houston Convention 2025 is canceled for any reason, the liability of the Event Organizers is limited to the refund of the registration fee. The Event Organizers are not responsible for any other costs incurred by the Attendee, including but not limited to hotel, travel, or other related expenses.

#### 3. Hotel and Travel Bookings

The Attendee is solely responsible for all hotel, travel, and other related bookings. The Event Organizers are not responsible for any issues arising from these bookings, including but not limited to overbookings, cancellation fees, or discrepancies in room rates. No refunds will be issued to individuals who are removed from the Event for these reasons.

## 7. Photography and Videography Release

By attending the Event, the Attendee grants the Event Organizers the irrevocable right to use their likeness, image, voice, and/or appearance in photographs, video recordings, or other media captured during the Event. This content may be used for promotional, marketing, or archival purposes without any compensation to the Attendee.

#### 8. General Disclaimer

This disclaimer policy is governed by the laws of the State of Texas. Any and all disputes arising from or relating to this policy or the Event shall be subject to the exclusive jurisdiction of the state and federal courts located in Houston, Texas.
